Sub: Proposed initial public offering of equity shares by Regaal Resoures Limited (Company) comprising a fresh issue of Equity Shares (Fresh Issue) and an offer for sale of Equity Shares by Selling Shareholder(s) (Offer for Sale, and along with Fresh Issue, hereinafter collectively referred to as Offer)

This refers to correspondence on the above issue resting with your letter dated 06.11.2024. You have mentioned that Regaal has approached SEBI seeking an exemption from disclosing our name as member of the company's promoter group & from making the necessary disclosures. You have also mentioned that SEBI vide its letter dated October 10, 2024 has refused to accede to your request for exemption and has made certain directions including to classify us in Promoter Group.

We have perused the SEBI letter dated October 10, 2024. From its perusal, it is clear that you have failed to bring out all the reasons for our refusal to be classified as member of promoter's group, resulting in refusal by SEBI. We request you to approach SEBI again seeking exemption narrating all the reason as stated earlier vide our letter dated 6th August,24

In this regard to above, we once again would like to confirm that:

- (i) The Company "SKJ Estate Private Limited" is not a shareholder of the Issuer or its Subsidiaries or any of the businesses owned or controlled by the Promoters of the Issuer.
- (ii) The Company "SKJ Estate Private Limited" has never been associated with Regaal Resources Limited as Shareholder
- (iii) The Company "SKJ Estate Private Limited" is distinct, separate and completely independent unit from the promoter of the issuer.
- (iv) The Company "SKJ Estate Private Limited" currently does not have any business, financial or any other interest whatsoever in the management, business and day-to-day operations of the Issuer or its subsidiaries or any of the business owned or controlled by the Promoters of the Issuer.
- (v) The Company "SKJ Estate Private Limited" has not furnished any debt facility, loan, security or guarantee to the Issuer or its subsidiaries or any of the business owned or controlled by the Promoters of the Issuer or availed any debt facility, loan, security or guarantee from Issuer or its subsidiaries or any of the businesses owned or controlled by the Promoters of the Issuer.
- (vi) The Company " "SKJ Estate Private Limited" does not have any control or influence over the affairs of the Issuer or its subsidiaries or any business owned or controlled by the Promoters of the Issuer, directly or indirectly.
- (vii) The Company "SKJ Estate Private Limited" does not have any special rights with respect to the Issuer or its subsidiaries through formal or informal arrangements.
